- The match will be conducted under SASS rules.
- Registration must be completed by May 30/23 and is limited to 60 registrants. Registration may be emailed to Dave Moore at 07dave12@gmail.com or mailed to Vermilion Gun Club, box 3174, Vermilion AB T9X 2B1. Please use registration form. Final classification will be determined at check in. Full fee can be sent through e-transfer to vermiliongunclub@gmail.com, by mailed in cheque, or at registration on Saturday morning.
- Cost for 2-day match is \$75.00 (\$65.00 for Vermilion Gun Club members) Extra Saturday meal tickets are \$25/person. Meal will be held after the swap meet and both will be at the Johnstone private campground.
- Range is located on NW22-49-06-W4. From Vermilion go south 6 km on Hwy 41 to TWP road 500, turn east on 500, go 3 km to RR 63 then turn south to the range at the end of the road.
- Registration will be at the range at 8:00 on Saturday the 3rd. Gates to the gun range will open at 7:30. Safety meeting will be at 8:45 with shooting to start right after.
- The meal on Saturday will follow the swap meet which will be from 4:00 – 5:30. Both will be at the Johnstone campground.
- A match copy will be emailed where possible to registrants after the May 30th cut-off. Additional copies will be available at check in.
- Range setup will start at noon Friday 2nd. Volunteer help greatly appreciated.

- Practice will be permitted Saturday evening for those interested. Please just use stage 1.

Accommodations

- Unfortunately, there is no camping at the range.
- For those with trailers or wanting to camp we recommend the Johnstone private campground which is only 3 miles from the range. The swap meet and meal will be held there. There are 11 sites with power and water for \$30/night and will be available on a first to register basis, so register early. There are also numerous dry camping sites at \$10/night. Contact Blaine Felt at blaine.felt58@gmail.com or 780-581-5286 to register there. Fees for the campground can accompany registration fees. Easiest access to the campground is from Hwy 16, 1 mile east of Hwy 41. Turn south on RR 64 and go 1 ½ miles (2 km). Campground is on west side of road by RR64/TWP road 503 intersection. Ron Dyck is the campground manager, and a sign will be in front of his trailer unit indicating such.
- Vermilion Provincial Park is in Vermilion, and you can book online at AlbertaParks.ca.
- There is a free trailer dump located behind the Shell station in Vermilion along Hwy 41.
